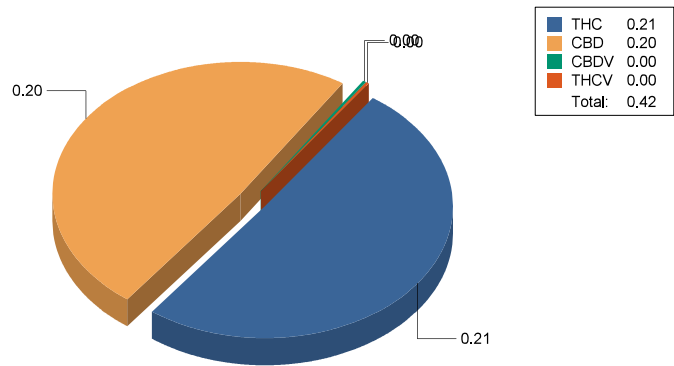




Potency - THCV and CBG exceeded normally accepted RPD criteria in the Sample Duplicate due to relatively large variations in very small values.


